Derby Festival Community Champions Sponsored By Amazon

A "Community Champion" is defined as a person who has devoted themselves to sustained and selfless service during these unprecedented times.

Examples include (but are not limited to):

- Neighborhood Champions: Individuals or businesses who have demonstrated their desire and willingness to help or brought awareness to those in need of assistance (monetary, supplies, etc.).
- **Medical Champions**: This is both the Frontline workers like nurses, emergency medical responders, and doctors, but also the backline medical workers like researchers, pharmacists, lab technicians, therapists, medical personnel for their heroic work in providing aid.
- Warehouse and Delivery Champions: Packaging, processing & fulfillment personnel, delivery
 persons, and postal workers who have provided the highest standard of customer service and
 dedication to keep our community safely supplied.
- **Education Champions**: Teachers, school administrators, janitors, and other workers in education for their extra efforts to keep students safe, informed, and educated.
- **Government Champions**: Government employees who have gone above and beyond the call of duty to keep our community safe and informed.
- **Media Champions**: Reporters, editors, on-air personalities, and other media figures for their work to keep our community safe and informed.
- **Public Service Champions**: Firefighters, social workers, law enforcement, sanitation workers and other public service personnel for their heroic work to keep us healthy and safe.
- **Retail or Food Service Champions**: Retail and food service workers for their contributions to keep our community safely supplied and fed.

The following are the elements that are required in an official nomination for the Community Champions Sponsored by Amazon:

- Name of individual submitting nominee
- Nominee's Name/Entity (if a business)
- Nominee's address
- Nominee's phone number
- Nominee's email address
- A description in 150 words or less on what makes the nominee a Community Champion, including specifics about the person's occupation or activities that make them a Community Champion.
- Photos/videos of nominee(s) are encouraged though not required.

Nominator should have the permission of the Nominator to nominate him/her as part of this Champions Program.

Self-nominations will be accepted. Nominations may only be submitted in the name of a single person; group nominations are not acceptable. Nominee's community services cannot be done on behalf of or be affiliated with a political and/or religious organization. Nominations are valid for a period of one year. There is no limit on the number of Nominees a Nominator can nominate; however, a Nominator may only nominate any Nominee one (1) time.

Multiple nominations received for the same Nominee from a single Nominator will be void. False or deceptive nominations or acts may render a Nominee ineligible. All nominations become the property of Promoter and will not be returned.

Nomination must be true and verifiable and the original work product of the Nominator. No part of the Nomination may have been previously published, have won previous awards, or infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity.

Prohibited Content: Nomination may not contain, as determined by the Promoter, in its sole discretion, any content that:

- is sexually explicit or suggestive; is obscene or offensive; unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group; profane or pornographic; endorses any form of hate or hate group; contains nudity;

 private figures, living or dead; contains look-alikes of celebrities or other public or private
 figures, living or dead;
- communicates messages or images inconsistent with the positive images and/or good will with which Promoter wishes to associate;
- and/or violates any law, rule or regulation.

If the Nomination contains any material or elements that are not owned by the Nominee and/or which are subject to the rights of third parties (e.g., the video was filmed by someone other than the Nominee), the Nominee is responsible for obtaining, prior to submission of the nomination, any and all releases and consents necessary to permit the use and exhibition of the nomination by Promoter in the manner set forth in these Terms. Promoter reserves the right to request proof of these permissions in a form acceptable to Promoter from any Nominee at any time. Failure to provide such proof, if requested, may render nomination null and void.

4. Publicity Grant/Use of Nominations:

By submitting a nomination, participants (both Nominees and Nominators) hereby grant to Promoter and its designees, successors, licensees and assigns a nonexclusive license to edit, modify, reproduce, distribute, display, perform, create derivative works based upon, or otherwise exploit the nomination and all elements embodied therein, in whole or in part, including, without limitation, their names, cities and states of residence and likenesses, voices, performances, and/or images in any manner, in any and all media, now known or hereafter devised, throughout the world in perpetuity, for advertising, promotional and other purposes, without further compensation, notification or permission. Participants agree that Released Parties (as defined below) are not responsible for any unauthorized use of nominations by third parties. Promoter has no obligation to make use of the rights granted herein.

5. Judging for the Community Champions Award: Promoter will review all eligible nominations received to determine a Community Champion based on the following judging criteria:

- Level of commitment to supporting others and the community through their actions and activities.
- The impact that the nominee's work in the community and that their work has made a difference to those being helped.
- Initiation of good citizenship through their actions and activities.
- Commitment to sustained and selfless service to others and the community.

Promoter reserves the right not to provide all awards if, in its sole discretion, it does not receive a sufficient number of eligible and qualified Nominations. Promoter will not reveal the judging scores for any Nomination. The decisions of the Promoter and judges will be final and binding.

Non-winning nominations will carry forward into subsequent judging periods, if any. If more than one nomination is received for a particular Nominee, Promoter, in its sole discretion, may consider any of the nominations for that Nominee in its judging. Whether a Nominator is identified and which Nominator is identified, if there are multiple nominations for one individual, is in the sole discretion of Promoter.

Nominees may be contacted to provide additional information and have their information verified. Promoter reserves the right to conduct research (i.e., review website, and personal social media pages and/or request and require additional information from nominees in order to have their nomination considered.

- **6. Notification and Publication:** Potential Community Champions will be notified by phone and/or email and may be required to submit additional information. If, despite reasonable efforts, a potential Community Champion does not respond within seventy-two (72) hours of the first notification attempt, or if the notification is returned unclaimed or undeliverable, such potential Community Champion will be disqualified and a runner-up for that judging period may be notified, in Promoter's sole discretion. Potential Community Champions must agree to participate in promotional campaign with Promoter, which may include photographs and/or in person interviews. For any reason, if a potential Community Champion declines, such potential Community Champion will be disqualified and Promoter reserves the right to select an alternate Community Champion.
